

### Storyline and Show Organization

Generally we will sequence the show in the order in which the event occurred. For example, depending on the scope of the images provided a general Memories with Style outline might look something like this:

- a. General shots of the couple's life together from the time they met to just before the wedding day
- b. Getting ready for the wedding
- c. Wedding
- d. Abstract shots of flowers, dress, ties, symbolic items of any kind
- e. Some wedding party images (bride & groom with parents, wedding party, etc.)
- d. Reception

Your show will simply depend on the type and quantity of images provided for inclusion. For organizational purposes we'll ask that you provide us with the file names of the images for each category defined above. Although there may be some overlap, this allows us to get started on the show right away and not spend too much time trying to figure out what order (or category) the images should appear in the show. Once the show is booked, we'll develop the general outline and photo locations with your assistance via email and/or over the telephone. The simplest method is for you to create category folders and put the images in the appropriate folders.
